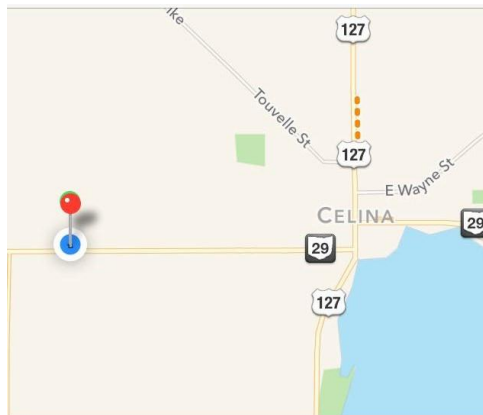

Diagnostic Assessment- Our Counselors conduct a thorough assessment at the first visit to diagnose problem areas and provide an effective treatment plan.

Case Management- For individuals who need additional support with regular monitoring and services. Our case managers provide advocacy and assistance with a wide variety of needs and issues.

Psychiatric Services- Our medical personal can help with prescribing and monitoring psychiatric medications to decrease symptoms and speed up recovery.

Crisis Intervention- For individuals experiencing crisis situations who need help immediately, our trained counselors provide rapid and effective intervention to stabilize the person.

We accept Medicaid, Medicare, most health insurance coverage, as well as VISA, Mastercard, and Discover Card. Foundations also offers a sliding fee scale through the Tri-County Board.



Drug and Alcohol Services

Counseling- Drug and Alcohol Counselors are available to those in need of addiction services with a certified professional counselor.

Case Management- For individuals who need assistance with daily life skills and community resources, Foundations offers professional case managers for monitoring and support.

Support Groups- Foundations offers a wide variety of support groups to learn how to deal and cope with addiction.

Drug Testing- Foundations helps with keeping you accountable with in-house drug testing.

Mercer County Common Plea Drug Court- Mercer County offers a drug court program that is an 18 month outpatient program for addiction purposes. Please contact Foundations for eligibility.

Medication Assisted Treatment- We collaborate with local physicians to ensure good continuity of care with Medication Assisted Treatment.
